Light Duty Policy TFD

Chief Crews discussed an outline with the Committee reviewing a proposed Light Duty policy for the Fire Department. Much discussion was related to either work related light duty and non-work related light duty. During the meeting it was determined at this time to remove paragraph B from the proposed policy and to research that section and come back next month to discuss that portion of the policy.

Motion by Alderman Jones and seconded by Alderman Burtle to recommend to the City Council to accept the TFD Light Duty policy with removal of paragraph B at this time and to implement. Motion carried 4-0.

Social Media Policy TFD

Chief Crews discussed an outline with the Committee reviewing a proposed Social Media policy for the Fire Department. After reviewing the proposed policy, the Committee would like to remove the words Higher Ranking Officer to replace it with Captain or SOIC in paragraph 4.

Motion by Alderman Olive and seconded by Alderman Jones to recommend to the City Council to accept the Social Media Policy with change to paragraph 4 and to implement. Motion carried 4-0.

Training Reimbursement Policy

Chief Crews discussed an outline with the Committee reviewing a proposed Training/Education and Equipment Reimbursement Policy for the TFD. After much discussion, the Committee would like to see the new employee sign this policy at time of conditional offer of employment and to understand that if the employee should leave the TFD before 4 years, the employee will be responsible to pay back the City of Taylorville 100% of Training, Education and Equipment charges incurred. At one day after the 4 years, the new employee will not be responsible for

reimbursement to the City of Taylorville. The Committee believes this will help with retaining the Firefighters. It was suggested that the Police should review the policy.

Motion by Alderman Jones and seconded by Alderman Burtle to recommend to the City Council to approve the proposed Training/Education and Equipment Reimbursement Policy as written with the necessary changes. Motion carried 4-0.

Firefighter Position

Chief Crews is requesting the Committee to allow him to replace a firefighter as he has received a resignation from a firefighter.

Motion by Alderman Olive and seconded by Alderman Burtle to recommend to the City Council to direct the Mayor to send a letter to the BFPC to hire a replacement contingent upon signing the Reimbursement Policy.

On November 22, 2016, the U.S. District Court Judge granted an emergency motion for preliminary injunction and enjoined the Department of Labor from implementing the Overtime Rule on December 1, 2016. The Overtime Rule will not be in effect at this time.

Treasurer Nation was asked if the City had the available funds for this position. She will review the budget and expected revenues to confirm the status, and will report back to Chairman Vota with her recommendation.

Motion by Alderman Dorchinecz and seconded by Alderman Burtle to recommend to the City Council to bid and/or advertise for a Laborer in the Street Department upon confirmation of available funds by the City Treasurer.
